

2013 : A PUSH TO RESEARCH AT SAU



The year 2013 would be remembered as the year when we started a Ph.D. programme at the South Asian University. Even though it was our first admission to Ph.D. programme, we received surprisingly high number of applications. For about 35 Ph.D. seats in seven different academic areas, we received about 1200 odd applications. Finally 32 students were admitted to different Ph.D. programmes, 11 of whom are from outside India. SAU is meant to essentially be a research and post-graduate university and with the beginning of the Ph.D. programme, the research part of the university's mandate got a formal push. Special working space was created for Ph.D. students in the areas of Sociology, International Relations and Legal Studies in an ear-marked hall on the Mezzanine floor of the university. Ph.D. students in Biotechnology and Computer Science /

Mathematics were provided desks and chairs in their respective laboratories. With the start of the Ph.D. research, the state-of-the-art Biotechnology research laboratory at SAU started humming with research activities. Special care was given to make available on-line databases of research journals through the SAU Library. The eighth floor of Akbar Bhawan was renovated as a hostel for Ph.D. students. The Ph.D. programme will continue in coming years and by the time we expect to move to our own campus in Maidan Garhi, most possibly in the year 2016-2017, we shall have about 100 Ph.D. students in the university.

It has been noticed that many SAU students need extra help with their English language skills. We started a program to provide this help by establishing an English teaching cell. The expert hired for this purpose provided individual help to needy students. The SAU would sustain and further strengthen this programme.

First full batch of 145 students comprising M.A. / M.Sc. / LL.M. students passed out from SAU this year with M.A. / M.Sc. degrees. While convocation for degree distribution could not be organized this year because of scheduling problems, we hope to be able to do so in the year 2014.

DECISION MAKING BODIES OF SAU

GOVERNING BOARD (GB)

The Governing Board of the South Asian University (SAU) is the highest policy and decision-making authority of the university, which oversees the academic, administrative and financial management of the university. The Board is primarily responsible for the liaison with the SAARC Secretariat and SAARC Member States. It consists of two members from each of the SAARC Member States, nominated by the respective Member State, in the manner prescribed in the Regulations.

During the period under report, two meetings of the Governing Board were held on 27.05.2013 and 24.12.2013. Some of the important decisions approved in the Governing Board meetings under report, are as follows:

- The Annual Report of the University for the year 2012;
- The Annual Accounts together with Audit Report for the Financial Years 2010, 2011 and 2012;
- Appointment of University's Statutory Auditors;
- Introduction of Internal Audit System for the University;
- Creation of Gratuity and Leave Encashment Fund;
- Design of SAU Flag;
- Establishment of Quality Enhancement Cell and
- Amendment in Regulations and Bye-laws of the University.

EXECUTIVE COUNCIL (EC)

The Executive Council (EC) of SAU is the prime body responsible for major executive decisions. Besides senior functionaries of the SAU, the EC has four members who are nominated by the SAARC member states by rotation. The President of the SAU chairs the EC meetings. The Executive Council is vested with the powers to make teaching and other senior administrative appointments on the recommendation of the selection committees, fix their emoluments and define their duties. The Executive Council is also vested with the powers to maintain discipline amongst the teaching, and non-teaching staff in accordance with Rules, Regulations and Bye-laws and manage and regulate finances, accounts and other administrative affairs of the university.

The Executive Council meetings were held twice during the year under report on 08.03.2013 and 10.10.2013.

The Council deliberated upon various administrative and academic matters, and took important decisions. Some of the important decisions considered and approved by the Council are as follows:

- The recommendations of various selection committees for appointment of various faculty members;
- University policy and guidelines, including mechanism for prevention and redressing of sexual harassment and other acts of gender based violence;
- Management of outsourcing of services;
- Teaching Assistant Programme of SAU, and
- Nomination of experts on the selection committee for senior Non-Teaching positions.



ACADEMIC COUNCIL (AC)

The Academic Council (AC) is the custodian of academic activities of the SAU. It is vested with powers to recommend establishment and abolishment of Faculties, Departments, Institutions, Inter-disciplinary Research Centres, Specialized Laboratories and Libraries, etc. The Academic Council is also vested with the powers to recommend to the Executive Council the creation and abolition of teaching posts in the university, draft regulations regarding admission and examinations, appointment of examiners, conferment of honorary degrees and institution of fellowships and scholarships etc.

The Academic Council deliberated upon various academic matters in its meeting held on 31.7.2013. It also noted the factual data of admissions in various programmes of studies in the university in the academic year 2013-14 and declaration of results in respect of students of 2010-13 and 2011-13 batches. The Council also approved the format for award of Degree and Final Grade Sheets.

FINANCE COMMITTEE (FC)

The Finance Committee of the university considers the annual accounts, financial estimates and expenditure proposals. The annual accounts and estimates of the university, duly approved by the Finance Committee, are submitted to the Executive Council for approval.

The Finance Committee deliberated upon various financial matters in its meeting held on 26.07.2013.

The Finance Committee considered the Annual Accounts together with Audit Report for the financial years 2010, 2011 and 2012 as also Auditor's letter to management thereon and recommended to the Executive Council for approval of annual accounts together with Audit Report for the financial years 2010, 2011 and 2012. The Finance Committee noted the expanding level of operating activities in the university and also the Statutory Auditor's recommendation thereon, and recommended introduction of internal audit in the university.

The Committee also recommended creation of gratuity and leave encashment fund and approved that its investment be made by the Committee already constituted for the purpose of Corpus Fund.

SAU ADMINISTRATION

Being a young university, SAU is supported by a limited but efficient set of administrative staff. At present, there are only 42 non-teaching staff in the university. The head of SAARC is the Visitor of SAU. Prof. G. K. Chadha is the President of the university and Prof. R. K. Saxena is the Vice President. Deans are the heads of administration at the Faculty level, being supported by Chairpersons of each Department. Dr. A. K. Malik is the Registrar of the university.

UNIVERSITY FINANCES

The capital cost of establishing the university estimated to be roughly US\$ 440 million for the first phase (2014-17), as per the Inter-Governmental agreement on South Asian University, is to be completely borne by the Government of India. In addition, the Government of India has also provided free of cost, a 100 acre plot of land in South Delhi for setting up the main campus of the South Asian University. Operational cost of running the university is shared, on year-to basis, by all SAARC Member States and the contribution of individual Member States is governed by a formula that has jointly been evolved by the eight countries. Business Plan of the university that contains the university budget figures has been approved by the Governing Board of the university. The Operational and Capital Budgets for the year 2013 were US\$ 5.25 million and US\$ 3.25 million respectively.

HOSTEL FOR RESEARCH SCHOLARS

Understanding the need to prioritise accommodation for research scholars, the university renovated the 8th floor of Akbar Bhawan through CPWD and converted it to hostel rooms to accommodate M.Phil./Ph.D. students. The hostel rooms were furnished before being allotted to the scholars in July 2013. Hostel rooms are allotted currently on a sharing basis.

READING ROOMS

Fully air-conditioned reading rooms have been created for the students on the Mezzanine floor. The reading rooms, which are open 24X7, provide a quiet atmosphere where any student can study in any of the reading cubicles, which are structured ergonomically to facilitate disturbance-free study. There are separate rooms for the students of Master's programs and research scholars. The reading room for Master's students has a seating capacity of 38 while that of the research scholars has a capacity of 20 with a lockable drawer units.

MEZZANINE FLOOR HALL

The university created a fully air-conditioned multipurpose hall having 200 seating capacity on the Mezzanine floor. It has been further facilitated with two projectors and an advanced sound system. The hall is being used for various occasions such as seminars, workshops and special lectures by the Departments and Faculties.



MESS & HOSTEL COMMITTEE ELECTION

An election to elect the student members of Mess and Hostel Committees was conducted on 11 October, 2013 under the guidance of Dr. Senthil Kumar Venugopal, Assistant Dean - Student Welfare in SAU campus. Equal representation of the students from all the SAARC countries was ensured through the election. The electioneering process was a smooth and successful one.

MULTIPURPOSE FACILITIES

The porta cabins in Akbar Bhawan have been renovated to house multipurpose facilities that include student activity centre, laundry room and rest room for drivers, mess/canteen and maintenance staff. A multi-utility shop will also be opened soon where students can buy stationery and other materials for day to day use.

ADMISSIONS

The process of admission at the South Asian University begins with the breaking of multimedia admission advertisement campaign in major newspapers of all SAARC countries, FM radio stations and select TV channels. Exhaustive information detailing the admission process, eligibility criteria, feedback mechanism, details of admission volunteers and other related information were uploaded on the university website.

Online application system was introduced and became very popular amongst applicants. Downloadable application forms were also made available on the SAU website so that aspirants could have the option of taking print out of the forms, fill them up and send them to the university. Only after each application, received through both online and offline modes, was thoroughly scrutinized to ensure that each applicant met the minimum qualification to appear for the entrance test, admit cards for the entrance test were dispatched to the eligible applicants by email. A common entrance test was conducted simultaneously in 8 SAARC countries on 24 March, 2013. One test centre each was set up in Afghanistan (Kabul), Bhutan (Thimpu), Maldives (Male), Nepal (Kathmandu) and Sri Lanka (Colombo) while two centres each were set up in Bangladesh (Dhaka & Chittagong) and Pakistan (Karachi & Lahore). Understanding the large number of candidates and the wide geographical spread, 12 test centres were set up in different cities in India viz. Bangalore, Chandigarh, Chennai, Delhi, Guwahati, Hyderabad, Jaipur, Kolkata, Lucknow, Mumbai and Patna.





Most SAARC Member States had appointed/nominated Nodal Points to help and interact with SAU on all matters related to the conduct of the common entrance test. The university received full cooperation from the Nodal Point in each Member State. Since Pakistan did not appoint a Nodal Point, the university had to make private arrangements in Beaconshouse National University in Lahore and Federal Urdu University of Arts, Sciences and Technology in Karachi for the entrance test.

A total number of 4133 candidates applied for the programmes on offer. Of these, 3313 appeared in the test and 2166 qualified the admission test. Offer of admission was sent to 250 candidates.

The South Asian University strictly follows a recommended quota system to ensure representation of students from all the Member States of SAARC. Merit lists are prepared country-wise and candidates from the same country compete among themselves for the specified seats. Any seat left unfilled for any country gets filled up by students from other countries, as per SAU rules.

SCHOLARSHIPS

The SAU is committed to awarding scholarships/financial support to the needy and deserving students. Scholarships and financial support are granted under three categories – 1) Govt. of India sponsored **SAARC Silver Jubilee Scholarships (SJS)** which are provided to 100 students (75 from Master's level students and 25 from Doctoral students) coming from Least Developed SAARC Countries or LDC (i.e., Afghanistan, Bangladesh, Bhutan, Maldives and Nepal); 2) **SAU Financial Support (SAUFS)** which is granted on a need cum merit based system from SAU's own funds and 3) **President Scholarship**, the most prestigious category which is awarded to all those students who top in their respective country-wise merit list of SAU Entrance Test in each individual course, provided their rank falls within 10 percentile of the total number of candidates appearing in the Entrance Test and securing minimum prescribed qualifying marks.


Both SJS and President's Scholarship carry full scholarship covering full tuition fee waiver and living allowance amounting to INR 1,32,400 per year for Master level students and INR 1,92,400 per year for Doctoral students. The scholarship holders also enjoy free hostel stay. In addition, all students who have been granted Silver Jubilee and President Scholarship, also receive an amount of INR 10000 (non-Indian students), and INR 5000 (for Indian students) respectively, towards "start-up" allowance in order to meet part of their travel cost and books-purchase allowance.

After the admission process for the year 2013-14 was over, applications were invited from students for scholarship/financial support. 272 Master's students applied and they were invited for a face-to-face interview before the Scholarship Committee so as to assess eligibility and quantum of financial aid that would enable each applicant to continue his/her studies at SAU without undue financial hardship. The Scholarship Committee granted scholarship and financial support to 269 Master's students: Afghanistan-24; Bangladesh-47; Bhutan-10; Maldives-1; Nepal-27; Pakistan-18; Sri Lanka-9; India-133. Three students did not turn up for interview.

Of the total number of recipients, full scholarship was awarded to 109 students from LDC, including 75 SJS, while 160 students were granted SAUFS with varied quantum of scholarship/financial support ranging from INR 24,000 to INR 1,20,000 per year.

Likewise, the Committee awarded scholarships to 31 Doctoral students who applied for scholarship and financial support, 11 of them being SJS (Afghanistan - 1, Bangladesh - 5, Nepal - 5), and 20 of them under the SAUFS category for an amount of INR 1,50,000 per year for each student. One Doctoral student already had fellowship from CSIR and hence didn't apply for scholarship.

For the academic year 2013-14, President Scholarships were awarded to four students, one from Bangladesh and three from India.



STUDENT ACTIVITIES

CULTURAL ACTIVITIES

South Asian University is a microcosm of South Asia. With students from all the eight South Asian countries, quite possibly the only such university in the region, SAU is a melting pot of South Asia's culture. The university sees creative expression of these cultures in various hues and sounds. Cultural events are regular in the university campus, the students of SAU also participate in cultural programmes outside the university.

INDEPENDENCE DAY CELEBRATION

On August 14 every year, in one quiet corner of India's capital, a group of students spearheaded by those from India and Pakistan do something that is usually quite unheard of – celebrating the Independence Day of India and Pakistan jointly.

For South Asian University, this celebration has been an annual feature. Celebrated with the same patriotic fervour as seen elsewhere on the Independence Day, Jashn-e-Azaadi was a two hour programme wherein the students of Pakistan celebrated their Independence Day starting at 11pm of August 14 and went on till midnight. They presented patriotic songs, cultural items, a documentary on Pakistan, speeches in Urdu and concluded with the national anthem of Pakistan. At the stroke of midnight, the floor was handed over to the Indian students who celebrated their Independence Day for the next one hour. The Indian students also presented cultural items and a documentary and concluded with national anthem of India.

Students from other countries such as Nepal, Bangladesh and Afghanistan also congratulated the students from India and Pakistan on their Independence Day and presented their experiences of living amidst students from different nations with varying cultural backgrounds.

FAREWELL PARTY 2013

Students of first year programmes of South Asian University gave a Farewell Party to the senior students who were passing out in May 2013. The event saw felicitation of senior students amidst loud cheers and the hunt for Mr. and Ms. SAU was a major highlight. Many cultural items were also presented by the first year students.









INTERNATIONAL MOTHER LANGUAGE DAY

Students of South Asian University celebrated International Mother Language Day with much fanfare. Cultural shows of all forms and literally 'languages' were the main highlights of the evening.

Following the proclamation by UNESCO in 1999, International Mother Language Day has been observed every year on 21 February the world over to promote linguistic and cultural diversity.

Diversity in the truest sense was the flavour of the evening – Afghan students singing Hindi film songs in Hindi as well as Farsi, recitation of poems in virtually every major language spoken in the South Asian Region, traditional and modern dance forms going hand in hand, ramp walk that showcased traditional attires and patriotic songs sung with a passion.

A number of students from Dhaka University were also invited by the students of South Asian University for the function. It is days like these that bring out the beauty of the cultural diversity of the region and it is functions like these that define South Asian University.







STUDENT FACILITIES & SERVICES

HOSTEL AND SPORTS FACILITIES

South Asian University provides hostel accommodation to its students on a sharing basis. Students from outside of India and Delhi are given preference. The hostels are located inside Akbar Bhawan across four floors and are currently housing 70 girls and 215 boys. There are separate hostels for boys and girls. An entire floor is dedicated to accommode M.Phil/Ph.D. students.

The common rooms of the hostels have basic sports and recreational facilities. Students also work out in the gym, which at present is a modest set up. The university stands committed to providing infrastructure and financial support for other sporting facilities.

HEALTH CARE FACILITIES

It would not be inappropriate to mention that 'health for all' by 2000 AD was a slogan which the WHO had framed keeping in mind, that, with the improvement of the hospitals, primary centres and community health centres and all health centres irrespective of its population and location a positive health status would be attained with the upgrading of health facilities. The same applies with the health centre of SAU where with time it has improved to an extent that students, the staff and the faculty and all others associated with this health centre are happy with the work and efforts the health centre staff has put in.

The health centre was started in August 2012. Gradually it has maintained its quality services and at present caters to a population of around 600 with minimum basic facilities necessary. It now also has a visiting Counsellor (Psychologist), who comes twice a week for 2 hours each.


The activities of the health centre includes full time OPD, nursing services, emergency medicines, injections, dressing, nebulisation, lab services in the form of a collection centre, referral services to higher centres for consultation to specialists and time to time inspection of the campus for preventive measures. Spraying every 15 days for mosquitoes is being done in and around the campus to reduce the spread of dengue and chickenguniea. Mess conditions are also looked into from time to time.

During the year under report, the health centre had about 1817 patients including staff and students compared to 896 students and staff the previous year. Proper referral services and immediate action for any medical problem is well dealt with. Number of students referred for admission has reduced to half of that of the previous year, taken into consideration the period of services in both the years.









SAU LIBRARY

The South Asian University Library was established to fulfill academic and research need of the students, faculty members and other users of the library. The current library spreads over a total area of 4500 sq. ft. The library functions from Monday to Saturday from 9:00 am to 5:30 pm. The reading rooms in the Mezzanine floor are opened 24 hours a day, the whole week.

The library has text and reference books and journals covering different subject areas i.e. Computer Science, Mathematics, Religion, Biotechnology, Sociology, Economics, Law, International Relations, Geography, History etc. Library resources include close to 10,000 copies of books, more than 300 e-books, 7180 e-journals, CD/DVDs, journals, newspapers, magazines and e-database.

The library provides a wide range of services that include Circulation (lending service), Access to Physical and Virtual bookshelf, OPAC with Library 2.0, Current Awareness Service (CAS), Full-text Journals, Online Database, Integrated Search Facility, Inter Library Loan and Reference.

University Library is a member of DelNet (Developing Library Network), Library members can send their loan request for book from member institutions from India, Sri Lanka, Nepal and Pakistan from the DelNet website.

University Library uses Integrated Library System Koha that extends its Library 2.0 technology facilities to the patrons. Using this system, patrons are able to customise their user profile, subscribe RSS feed, get notified by auto email, send book purchase request, hold or reserve an item, create their private book list, share item list, comment, tag, rate any item, look into search history, view most popular books, check borrower status, link with online social network, etc.

During the year under report, the library purchased around 2,000 books worth approximately INR 41,00,000 and subscribed online journals and databases worth approximately INR 3,71,62,000. More than 7,236 articles were downloaded by library users. The library also added 236 new members.

SAU Library organised Book Exhibitions on 6 - 8 August and 12 - 14 August 2013 in front of the library where students and faculty members selected around six hundred books to be purchased for the University Library.

On 19 August 2013, SAU Library organised a user orientation programme for the students and faculty members.

THE WRITING CLINIC

During the year under report, The Writing Clinic was initiated for all those students in SAU who need help in language matters. English for Academic Purposes course was designed for all SAU students. This learner-centric, need-based course aimed to provide an academic writing course to meet the specific needs of the post- graduates and research scholars of SAU. Furthermore, the course aimed to develop awareness of the elements and conventions of academic writing and to encourage students to develop their writing skills through guided practice and feedback. The course focussed on Academic Writing, Language Elements, Academic Vocabulary in use, various Elements of Style - Diction, Syntax, Point of View, Tone, Theme; Reading Comprehension with special focus on Contextual and Structural Clues, Notation and Citation; Plagiarism, Paraphrasing and Summarization Skills, Mind Mapping for Academic Writing, Academic Conventions etc. to name a few. In addition to the classes the key feature of the Writing Clinic was the appointment system to address the individual concerns of the students. It is a free service for all the SAU students that offers one-to-one help with writing assignments.

SOUTH ASIAN STUDIES

A compulsory non-credit course titled 'Introduction to South Asia' was introduced from the January 2013 semester. All final semester students are required to take this course. Passing of this course is mandatory for any student to get his/her Master's degree of this university.

A minimum of 75% attendance in this course is a must. In case any student who fails to maintain the prescribed 75% attendance or does not pass this course, he/she will not be eligible for the award of Master's degree.

This course introduces the students to the history, common issues and challenges of the South Asian region.





FACULTY OF ECONOMICS

Dean's Remark

2013 was an important year in the process of building up the faculty of Economics as a leading centre of teaching and research in the South Asian region. The second batch of M.A. students in Development Economics graduated this year and have been placed in a variety of institutions across the region. Many of them are also preparing themselves to pursue further education. We also welcomed a group of accomplished colleagues who joined the Faculty later this year. Their enthusiasm and academic capacity will surely add a lot to the Faculty. All in all, we are looking forward to an even more successful 2014.



FACULTY OF LEGAL STUDIES

Dean's Remark

The Faculty of Legal Studies is engaged in the study of law subjects, systems, theory and institutions. Towards the end of the first semester, the LL.M. Programme (2013) provided an opportunity to study courses on: International Law, Legal Theory, Legal Research Methodology and Comparative Constitutional Law of SAARC Nations. The last two courses were offered by the Faculty keeping in view that the LL.M. Programme had students from the SAARC region and also the need for developing an inter-disciplinary approach to the study of law.

International Law has become the common language of international relations. To build a strong foundation for future research abilities of law students, the Faculty offers a course on the general principles of international law in the first semester. Among other academic benefits, this course enables students to understand the relationship between domestic law and international law in each one of the SAARC member states.

In 2013 the Faculty introduced the M.Phil/Ph.D. programme with the objective of promoting research in the field of International Law with special reference to the SAARC region. This programme has two foundational courses: Advanced International Legal Problems and International Economic Law. The Faculty aspires to be a fountain of high quality works emerging from research scholars with the help of their M.Phil. dissertations and Ph.D. theses.

Besides traditional methods of teaching and research, the Faculty adopted seminar methods, wherein weekly seminars were organised. Eminent law scholars from India and other countries interacted with the faculty members and students during the seminars. The Faculty also organised discussions on contemporary topics of international law.

During the period under review, faculty members participated and presented papers in national and international conferences/seminars/workshops. Some of the faculty members were also invited by law schools in India and abroad as judges in international moot court competitions.





The Department of Mathematics was established in the year 2012 with a vision of being one of the best departments in applied research and teaching that would cater the needs of quality manpower in academics; research and development organizations; and industry in the SAARC region. It offers courses and programmes of study which ensure that students will be able to contribute to the contemporary society and develop abilities to critically assess numerical and graphical information; learn to formulate strategies for solving problems; and acknowledge the importance of being intellectually curious throughout. Keeping in view the application of Mathematics across almost all disciplines, the Department has offered programmes in Applied Mathematics leading to M.Sc. and Ph.D. degrees. In 2012, it started a unique and more focused Master's programme, an updated curriculum with an adequate emphasis on theory, computation and applications. Moreover, the Department is committed to keep the curriculum dynamic so that the latest trends/demands of the society would be taken care of. In 2013, the Department initiated a Ph.D. programme with an objective to generate quality human resource for teaching, R&D organisations and industry. At present, the Department of Mathematics consists of eight regular faculty members. Their broad research areas include Numerical Analysis & Scientific Computing particularly Computational ODEs and PDE; Discrete Mathematics specially Graph Theory, Optimization specially Swarm Intelligence Optimization; Analysis & Functional Analysis especially Function Spaces, Weighted Norm Inequalities, Operator Theory, Statistical Approximations; Mathematical Modelling and Dynamical Systems. The Department organized several academic training programmes such as three 2-day Symposia and a 5-day instructional workshop and invited lectures and seminars by eminent mathematicians in 2013.



Dean's Remark

The Department of Computer Science is one of the first two departments established by the university. The Department initiated its teaching activities through a postgraduate programme in Computer Applications in 2010 with a total intake of 30 students. In 2011, the programme transformed to a more focused, rigorous and intensive programme as the faculty strength of the department increased. At present, there are two batches of Masters' students at different stages of their curriculum. This year, the Department has also started Ph.D. programme as part of the university's vision plan to strengthen research activities. The Department has proposed an intensive and unique research programme with an early exit option of an M.Phil. Degree. To create an experimental setup for the doctoral and masters' research, the Department has instituted a state of the art infrastructure with one general purpose computing laboratory and six specialized laboratories. The Department envisions setting up world class research environment and facilities in the areas of Artificial Intelligence and Machine Learning; Computer Graphics and Image Processing; Computer Networks and Mobile Computing; Data and Text Analytics; Distributed Computing; and Embedded and Real-Time Systems. The Department organized several academic and training activities in the calendar year 2013 such as CSIR sponsored Symposium on Image Processing and Pattern Recognition (S-IPPR 2013), an International Workshop on Machine Learning and Text Analytics, and invited lectures by eminent speakers on topics of contemporary interest, and other training programmes for all round grooming of students.

The faculty members of the department served as reviewers to many reputed journals: IET Image processing, Applied Mathematics and Computation (Elsevier), Digital Signal Processing (Elsevier), Real Time Image Processing (Springer), Fuzzy Sets and Systems (Elsevier Science), Neurocomputing (Elsevier), Computer Methods and Programs in Biomedicine (Elsevier), Pattern Recognition Letters (Elsevier), Knowledge and Information Systems (Springer), International Journal of Systems Science (Taylor and Francis); and Data Mining and Knowledge Discovery (Springer).
- 6. In the last two years, we built five research labs focusing on major research areas of the department i.e. "Image Processing and Pattern Recognition", "Real Time Systems", "Hardware Modeling and Simulation", "Wireless Networks" and "Text Analytics and Intelligent Systems". These labs facilitate research work of M.Sc. and Ph.D. students of the department.











DEPARTMENT OF SOCIOLOGY

Dean's Remark

The Department of Sociology in the Faculty of Social Sciences is one of the two constituent departments in FSS. It started operations in 2011 and now has the services of nine faculty members from four countries in the South Asia region. After successfully handling its M.A. program since 2011, it initiated its M.Phil./Ph.D. program in 2013. In March 2013, the Department of Sociology organized a conference on the theme, Mapping Changes and Transformations in Educational Systems and Discourses: Issues, Possibilities and Strategies making it the first conference organized by the Faculty of Social Sciences as well as the university. The Department of Sociology has identified a number of courses among its M.A. and Ph.D. courses that can be offered as interdisciplinary courses to all SAU students with an interest from January 2014 onwards. The Department has also co-organised an on-going series of internal workshops and discussions with the Department of International Relations titled Conditions of Knowing in order to broadly debate the ideas of interdisciplinary among faculty members and Ph.D. students in the Faculty of Social Sciences. The Department of Sociology played the pioneering role in designing and implementing the 'Writing Clinic' for all students in SAU who need help in language matters. In 2013, as part of the outreach work of the FSS, the Department of Sociology invited Prof. Gananath Obeyesekere from Sri Lanka to deliver the first 'Contributions to Contemporary Knowledge' lecture and Prof. Romila Thapar to discuss issuing in dealing with the past as part of the 'Exploring South Asia Lecture Series.'



In 2012, the Department of Sociology initiated discussions with Sage India to publish its own journal, *Society and Culture in South Asia*. Edited by an editorial board consisting of members of the Department of Sociology and an international editorial advisory board, the journal is open to social sciences and humanities with a focus on South Asia. It is based on the model developed by the journal, *South Asia Journal for Culture* published in Colombo from 2009 to 2012. Having commenced planning and editing in latter part of 2013, the first issues are scheduled to be published in 2014.

4) Thinking Through Theory: Photography Exhibition by First year MA Students

As an annual event and part of the course, Sociology Theory 2, first year MA students put together a photography exhibition in the university lobby incorporating selected written text to bring into focus pictorially the understandings of social theory they had mastered in the classroom.

5) Mapping Changes and Transformations in Educational Systems and Discourses: Issues, Possibilities and Strategies

Faculty coordinator: Ravi Kumar

A two day seminar was organised by Dr. Ravi Kumar from 21-22 March 2013, on behalf of the Department of Sociology at South Asian University, supported by Rosa Luxemburg Stiftung, Berlin. The seminar focussed on the challenges thrown up by the impact of neoliberalism in the arena of education. Ten papers on different issues such as the language question, education policy, ethnographies of neoliberal impact as well as the possibilities of using ideas of Mahatma Gandhi, Jyotiba Phule and B.R. Ambedkar as sources to resist neoliberalisation of education were presented. The seminar ended with a panel discussion where academics and activists debated the nature of crisis that education is faced with.

Dean's Remark

•The Department of International Relations in the Faculty of Social Sciences is one of the two constituent departments in FSS. It started operations in 2011, and now has the services of nine faculty members. After successfully handling its M.A. program since 2011, it initiated its M.Phil./Ph.D. program in 2013. On 23rd October 2013, the Department of International Relations successfully organised an international seminar on the Changing Scenario in Afghanistan: Implications for South Asia. The university-wide mandatory course, 'Introduction to South Asia' was designed and hosted by the Department of International Relations in its first phase of implementation in 2013. The Department also identified a number of courses among M.A. and Ph.D. courses with a view to offer them as interdisciplinary courses to all SAU students with an interest from January 2014 onwards. In collaboration with the Department of Sociology, the Department of International Relations co-organised an on-going series of internal workshops and discussions titled Conditions of Knowing in order to more broadly debate the ideas of interdisciplinary among faculty members and Ph.D. students in the Faculty of Social Sciences. Construction of SAU Campus at Maidan Garhi

The SAU has been physically handed over 93.68 acres land at Maidan Garhi for construction of the University's campus. Out of this land 10.58 acres are under the High Court Stay Order due to some litigation cases.

The Master Layout Plan of the campus has been prepared and almost all statutory approvals/ clearances have been obtained except the final approval by the municipality.

The Architects and the Project Management consultants of the project duly appointed by the University are on the job of preparing detailed planning, designing, detailing and other measures to obtain the approvals of the statutory authorities like Delhi Urban Arts Commission (DUAC), Delhi Fire service, South Delhi Municipal corporation for individual buildings/services.

The Building & Works Committee (BWC) of the University which is a high powered body of technical professionals and administrators meets periodically to lay down policies, review the project activities and monitor progress. Frequent periodical meetings are held between the SAU, Architects & PMC with the association of nominated members of the BWC to take decisions on day to day issues.

The BWC has since finalised the Strategy for execution of the total project activities divided into three packages. The Tender for invitation of bids for the 1st package, namely for boundary wall, gates, security hut, internal roads & civil works for external services termed as "Mandatory Package" is being issued shortly. The estimated cost of this package is Rs 27.69 crores. The preparation of designs, drawings & details of other two package works are under process. The tenders for these packages will be issued after the revised/ project cost is approved by the Govt, which is under process. The estimated project cost is approximately Rs 2100 crores. The expected time of completion of the campus in all respects is 48 months from the date of start of the second package works for construction of various buildings.

The University campus will be environment friendly and adopt energy conservation measures to achieve Green Building Certification of GRIHA-LD Rating 5 star.
