Politics of food and foodways: Taste, Health and Nutrition

### Aim and objective of the course

The main objective of the course would be to introduce the students to what contributes to the making and circulation of 'food' and 'foodways' in contemporary times. Every society has its own norms, and regulations around what is to be produced and consumed as food. Food plays an important role in social organization and hence is not immune from the politics around its control and distribution. The principles and practices of what is to be cooked, eaten, distributed and wasted contributes to the making of foodways. Therefore, foodways provide an interesting analytic to study what counts as food.

A study on food—ways is shaped by politics of food availability, food production and food distribution. Food availability is shaped by the changing relationship between humans and non-humans. Recent discourses on health and nutrition has pointed to a need for a multispecies approach to understand how bacteria, microbes contribute to the sensorial appeal of the food, health, as well as a cause of health risks. Considering ideas of nutrition or health are not universal how do foodways contribute to changing meanings of nutrition particularly associated with eating. Given that food is a marker of difference, an object of conspicuous consumption, source of status and prestige a close introspection of contemporary foodways will reveal how 'healthy' foods are marketed as free of sugar, cholesterol. How do these shape politics of food, thereby gendered notions of body?

## Brief summary of the course outline

To do so the course will begin with anthropological approaches to the study of food and nutrition with a special emphasis on how 'senses' played an important role in the making of food. A discussion on senses, remains incomplete without a cross cultural comparison of nutrition, senses and food with a special focus on taste, touch and smell in cultures of eating. Reproduction of senses as studies on food craftsmanship and agriculture will show requires a close readings of intersections of human – nonhuman and its impact on creating 'health'-y food. The final section would be on food, body and heath to understand cross cultural meanings of nutrition in the making of food ways.

### **Unit 1: Introduction to food and foodways**

In this unit the students will be introduced to theoretical approaches to the study of food and nutrition and how it has shaped ideas around politics of food.
