Part II

Course Overview

International trade law has become more important today due to unprecedented developments in international trade relations in the last few decades. The Uruguay Round of trade negotiations, the eight and last round of GATT trade negotiations, brought about major changes in the international trading system and led to the establishment of the World Trade Organization (WTO). The majority membership of the WTO now consists of developing and least-developed countries. The implementation of the WTO obligations of these countries has been presenting added difficulties as these obligations, it is argued, have shrunk the policy space for these countries. It is therefore important for the student to understand both the legal and institutional framework of the WTO.

Course Objectives

The objectives of the course are to equip the graduate student with the necessary knowledge and skills of international trade law contained in the WTO agreements and with emphasis on the South Asian countries.

Course Outcomes

Successful completion of the course should enable the student to understand the law and practice of international trade law, covering the implementation issues under several

WTO agreements, including trade in goods, TRIPS and GATS agreements and particularly for the South Asian countries.
